

Request for Final Bids COSTCO COLD & DRY DEPOT ADDITION PHASE 1 & 2

<u>SCOPE OF WORK:</u> Site – 19.82 acres, Depot Addition – Dry = 54,296 SF, Cold = 54,208 SF, and Offices = 3,135 SF - including, but not limited to: On-Site - Survey, Erosion Control & SWPPs, Select Site Demolition, Earthwork, Wet Utilities, Asphalt Pavement Patching, New Asphalt Paving, Pavement Markings, Site Concrete, Site Lighting, Perimeter Fencing, Select Building Demolition & Temporary Protection, CIP Building Concrete, Precast Concrete Wall Panels; Penetrating Sealer/Hardener, Joint Filler, Cold-Formed Metal Framing, Misc. Metals, Misc. Carpentry, Insulation, Joint Sealants, Installation of Doors/Frames & Finish Hardware, Metal Studs & Drywall, Ceramic Tile, Acoustical Ceilings, Resiliant Base, Polymer Flooring, Painting, Signage, Restroom Partitions & Accessories, Wall Protection, Misc Spec, Metal Building Systems – MBS (FOIC), Fire Sprinklers, Plumbing (FOIC), HVAC (FOIC), Building Electrical, Light Fixtures & Swithgear and Fire Alarm.

PROJECT SCHEDULE: Note there is a 3 month gap between cold start and dry start.

- 1. Cold Expansion Projected building construction start date is March/April, 2025.
- 2. Dry Expansion Projected building construction start date is June/July, 2025.
- 3. Substantial completion for both additions is December 8th, 2025.
